1784 - 1862  
Born Peachy Hall Freiston  
A man of two worlds  
Emigrating to America in 1819  
Returning to England in 1846  
5 men lost overboard in a terrible storm  
Owned a bookshop and lived on Pennsylvania Avenue, Washington DC  
from 1820 until 1836  
Sailed the Atlantic 4 times 1819,1829,1841,1846.  
Final resting place Abney Park cemetery Stoke Newington
