- 7.1¹ **Highways** Notification had been received regarding a temporary road closure on Butterwick Road, between the 28th and the 31st October 2019. The notice would be displayed accordingly.
- 7.1² Councillor Skinner reported that the problem with the culvert in Church End Road was being investigated soon.
- 7.1³ Mention was made regarding the severe dip in the road at Poynton Hall corner. Councillor Skinner stated he would report.
